Notice inviting applications to recruit Fard Kendra Executives

Director of Land Records, Punjab, Jalandhar invites applications from Indian Citizens for recruitment of **Fard Kendra Executives** to be posted in 155 Fard Kendra in the State of Punjab on contract basis. Fard Kendras are located in Tehsils and Sub-Tehsils in Punjab. The list of the Tehsils/Sub-Tehsils is given in the web-site of the <u>www.plrs.org.in</u>

Job-Profile

The Fard Kendra Executives shall perform functions for the smooth working of the Fard Kendras in the Tehsils and Sub-Tehsils. Fard Kendra is a single window service platform for providing land records and registration services to the citizens.

Service include

- all the matter relating to issue of Fards/Nakals of Land records,
- mutations of land records,
- receipt of court orders, and all applications regarding land records etc

The Fard Kendra Executive shall be a computer trained Land professional who will form the backbone of these services. He/She shall be well trained on all Land system matters; on software of the land records and registration; and on all processes of the Fard Kendras and Registration matters. He/She shall have hands on approach in the functioning of the Fard Kendras.

Educational Qualifications

- 1. BCA, B.Sc. (Computer Science) or Three years diploma in Computers.
- 2. Should have passed Punjabi up to Matriculate standard.
- 3. Adequate Typing speed in Punjabi Language on Ravi font.
- 4. Knowledge on land records system.

Age Limit

The candidate should aged between 18-37 years as on 1.1.2010.

Training

The selected candidates will undergo two months crash course training on Land Records System and application software of Land Records and Registration, Fard Kendra Manual and other important matters in the State Patwar School, located at Jalandhar. The State Patwar School has good hostel facility. The selected candidates shall be eligible for appointment as Fard Kendra Executive only after successful completion of the training for which their abilities will again be tested. Thereafter they shall be eligible for appointment in the respective districts.

Salary and perks

All appointments shall be made on contract basis initially for two years and the consolidated salary shall be 10,000/- (Ten Thousand only) per month along with TA/DA as per the Punjab Government Rules.

Contract Terms and Conditions

As elucidated above, the initial appointment for two years shall be on contract basis. The draft of agreement to be signed between Deputy Commissioner and Fard Kendra Executive is given in <u>www.plrs.org.in</u>

Reservation

Examination and Syllabus

The selection of the candidate shall be purely made on the basis of two examination papers given as under:

- 1. Paper-I (Revenue Law/Manual) 100 Marks
- 2. Paper-II (Knowledge on Computer Science and applications)...... 50 Marks

Both these exams shall be objective type. The candidate shall have to score at least 50% marks in each of the above papers to be eligible for merit list.

Syllabus

The detailed course material of the syllabus is given in the website <u>www.plrs.org.in</u>. The candidates are advised to prepare from this course material and they shall be tested from this course material.

Examination dates

The candidates are advised to take the printout of the course material from the website and study and prepare for the examination from the course material. The paper-I shall be based on the course material mentioned in the website. Period of approximately forty five days shall be given to the candidates to prepare for the examination from the 1st October, 2010. The examination dates shall be conveyed to eligible candidate in due course of time.

Type test in Punjabi for the selected candidates before joining the training.

The selected candidates can join the training only after clearance of type test in Punjabi (Ravi font) on Computer. The selected candidates will be given three chances to clear the type test within six months.

Allocation of districts

The Fard Kendra Executives shall be appointed district- wise and their cadre shall also be district -wise. Each candidate shall give preference for three districts of their choice and allotment of districts shall be based on merit and preferences opted for each category of reservation. The merit list for each reservation category shall be made separately and allocation of districts shall be made accordingly without any exception whatsoever. The reservation points shall be filled district wise as per the roaster points prescribed by the Government of Punjab from time to time.

Application form and fee

Candidate will send a non refundable Bank Draft for Rs 200/- (Rs 100/- for reserve category Candidates) in favour of "Member Secretary, Punjab Land Records Society, Punjab" payable at

Jalandhar along with the admit card/ Registration slip. The envelope containing the Application Form should have the title **"Application for the Post of Fard Kendra Executive".**
