In view of above, it was decided that Commissioner, Jalandhar Division should identify available land for these Court Rooms and prepare detailed plans by involving District Town Planner, Department of Architecture and PWD(B&R).

As desired, necessary amendments have been made to remove the budget deficit. After compiling, total expenditure to the tune of Rs.10395.39 lacs has been projected against estimated receipt of Rs.8860 Lacs (approximately) to be realized by way of user charges during the financial year, which shows the deficit of Rs.1535.39 lacs (Rs.10395.39 - 8860). Surplus funds to the tune of Rs.1544 lacs are lying as reserves as on 31.03.2017. The detail of expenditure proposed is as under:
