Confirmation of Proceedings of 42ndMeeting of Board of Management, PLRS.

Resolution 43.1

The Proceedings of 42ndMeeting of Board of Management, PLRS were sent to all the members vide this office letter No. **PLRS/BoM-42/538-47 dated9-03-2018**. Since no observations were received from any of the members, the Proceedings of the 42ndMeeting of Board of Management were confirmed.

Agenda Item No. 43.2

'Action Taken Report' on the 42nd Meeting of Board of Management held on 22 February, 2018.

Resolution 43.2

The 'Action Taken Report' on various Resolutions of 42ndMeeting of Board of Management was noted.

While discussing the Action Taken Report, the following points were emerged:-

With reference to Agenda Item No. 37.5, a sum of Rs. 25 Lac was released to DC, Ludhiana for completing the Scanning of Documents Project at 3 SROs, Ludhiana. DC, Ludhiana requested that more funds be released to him. After discussing the matter thoroughly, it was concluded that only Rs. 25 Lac more funds shall be released for the purpose. Further the Deputy Commissioner, Ludhiana was asked to truncate & conclude the Project with this amount only. Accordingly Utilization Certificate shall be furnished.

With reference to Agenda Item No. 40.14 regarding Cloud Service Provider, it was decided that details of hiring Cloud Service Provider will be submitted by DGR for further action.

With reference to enhancement of Land Records Application and upgradation of Software on Cloud Technology, it was brought out by DGR that Department of Governance Reforms had started working on the upgradation of the Application. But the progress in this regard was slow. He further elaborated that four Dot Net Developers along with one Database Administrator are to be hired. PLRS work has already been approved by PSEGS in the EC meeting held on 15 March, 2018. Since the hiring process may take a minimum of 2-3 months, he requested that he may be allowed to hire at least two Developers on outsource basis. It was resolved that DGR will have complete flexibility to hire the Developers to start the upgradation of the Application. However, he should submit the details of the hired-resources and the progress of the work in the next meeting of BoM, PLRS.

With reference to Agenda Item No. 41.3 regarding forming panel of Urdu Translators, DC, Ludhiana requested to issue the guidelines for forming panel of Urdu Translators. It was resolved that Deputy Commissioners may be authorized to hire the Urdu Translators on DC rates. In case of non-availability of DC rates, they are authorized to hire the Urdu Translators at DC rates of other Districts of Punjab where the panel has been formed.

With reference to Agenda Item No. 41.9 regarding revamping of website of Revenue Department, Punjab, it was brought out that the matter is under consultation with Department of Governance Reforms.

With reference to Agenda Item No. 41.10, it was noted that the letter for extension of Contract of existing BOOT Operator till 31st of July has been issued.

Regarding providing additional Connectivity to BSNL for upgradation of connectivity to all Revenue Offices, DGR informed that Department of Governance Reforms was working on the proposal to upgrade the connectivity across the State and he may require funds from Department of Revenue. It was resolved that DGR may submit the proposal w.r.t upgradation of connectivity at Revenue Offices and the funds may be provided from PLRS for this purpose.

Regarding improving the collection/receipt of PLRS, the following new services at Fard Kendras along with Facilitation Charges is recommended by BOM:-

Facilitation Charges for issuance of Fards: DC, Ludhiana raised a point that a large number of computerized pages in fards is being generated through the land records software. He suggested that Khasra-wise Fards should be generated to reduce the number of pages. After detailed deliberation on the issue, it was decided that software may technically be checked for providing Khasra-wise Fard instead of Khewat-wise Fard. After generating the Khasra-wise Fard, the

Facilitation Charges @ Rs.20 per page be recommended to the Government.

It was discussed that Fard Kendras are running very smoothly and it has a good impact on public. To provide better revenue-related services to the public, the new services shall be introduced at the Fard Kendras. After detailed deliberations with Divisional Commissioners and Deputy Commissioners it was decided that after following the new services system with the proposed Facilitation Charges, the proposal may also be sent to the Government for approval and introducing these services at Fard Kendras:-
